The New York State Department of Environmental Conservation (the Department) and the New York State Department of Health have reviewed the PFOS, PFOA and other associated perfluorinated & polyfluorinated chemicals (**PFAS vs PFCs** we may start to refer to **PFAS** analyte list and **not** PFC, since the term PFC is scientifically and technically inaccurate to describe these list of compounds, which actually describes 21 compounds, not just the 6 PFC compounds already sampled for in nearby public water supply) groundwater sampling work plan for the 14 groundwater wells at the Former New York Air National Guard and the Former Hangar B Septic Field Sites, dated October 16, 2017, prepared by Leggette, Brashears & Graham, Inc. (LBG). The PFC Sampling Work Plan is hereby approved.
